Tom McMillen is the CEO and president of the LEAD1 Association (formerly the Division 1A Athletic Directors Association). He joined the HSUS Board of Directors in 2013 and serves on the Governance committee.

Following a career as a professional basketball player, McMillen served three terms in the U.S. House of Representatives, representing Maryland’s 4th Congressional District from 1987 to 1993. He serves as a board member of Nexstar Media Group and as chairman of the National Fitness Foundation.

“My love of animals has added humanity to my life and empathy to my heart,” says McMillen, who also

serves on the board of the Humane Society Legislative Fund and supports numerous humane foundations. He and his wife live in Washington, D.C., and care for a variety of animals, including dogs, peacocks, guineafowl, chickens and finches, all of whom they consider members of their family.

David S. Niekerk (Washington) | 2019-

A dedicated animal advocate with a professional background in human resources, David S. Niekerk joined the HSUS Board of Directors in 2019 and serves on the Human Resources, Finance and Audit committees.

Niekerk also serves as the board chair of Jewish Veg and is a major supporter of Seattle Humane. Before retiring, he held leadership roles in human resources at Honeywell Aerospace, Mobil Oil, PepsiCo and Amazon. While working at Amazon, Niekerk helped establish a dog-friendly work environment and bring plant-based options to all company restaurants. Sharon Lee Patrick is the president of Patrick Partners Inc. Formerly, she was a partner of McKinsey & Company, founding the firm's media and entertainment practice, and co-founder and CEO of Martha Stewart Living Omnimedia (MSO). She is the architect of MSO's groundbreaking business model, coining the term "omnimedia," which has broadly transformed media and consumer retail branding and operations. She also led the creation of popular television networks including ESPN, AMC, Bravo and Martha Stewart Living.

Patrick joined the HSUS Board of Directors in 2008 and serves on the Finance, Human Resources, and Governance committees. She led the HSUS fundraising campaigns underpinning efforts to successfully pass Proposition 2 ending California's extreme confinement of farm animals; and the EU's legislation closing European markets to Canadian sealers, reducing the numbers killed from 218,000 in 2008 to 26,000 in 2021.

She is the vice chair of American Ballet Theatre and trustee of the Irish Arts Center and of Nazareth Regional High School. She was previously a trustee of Martha Stewart Living Omnimedia, Cablevision Systems, CMP, Lincoln's Cottage and World Monuments Fund. Patrick lives in New York City.

Marsha R. Perelman (Pennsylvania) | 2013-

Marsha Perelman is a former energy executive and a dedicated animal advocate who led the effort to pass two Pennsylvania laws to ensure commercially bred dogs get adequate care, including the major revision

in 2008 to the Pennsylvania Dog Law. She joined the HSUS Board of Directors in 2013, serves as chair of the Nominating committee and serves on the Executive, Audit and Governance committees.

Perelman started her career at Buckeye Pipe Line, where she was one of the company's first female executives. She co-founded Clearfield Energy and served on the boards of two New York Stock Exchange energy companies.

Passionate about helping animals, Perelman serves as a member of the Pennsylvania Dog Law Advisory Board and as co-chair of the Animal Care and Control Team of Philadelphia (ACCT Philly). She is a founding board member of Project Chimps, an HSUS-supported sanctuary in Georgia for chimpanzees formerly used in medical research. She also serves on the boards of The Fund for the School District of Philadelphia, which she co-chairs, and she chairs the board of Calder Philadelphia, a museum that will open in Philadelphia in 2024. Perelman lives outside Philadelphia with her husband, Jeffrey, and their many rescue dogs.

Thomas J. Sabatino, Jr. (Connecticut) | 2018-

Tom Sabatino, an attorney with nearly 30 years of experience as senior general counsel for global corporations, has long been involved in local animal rescue efforts in Florida and the Northeast. Driven by his desire to create long-lasting change for animals at the national level, Sabatino joined the HSUS Board of Directors in 2018 and was elected co-chair in 2019.

Through the Sabatino Family Foundation, he and his wife, Joan, support charities focused on animal welfare, education and people with developmental challenges. He is also passionate about promoting public interest law and empowering attorneys to advance social justice causes.

Sabatino is currently the executive vice president and general counsel of Tenneco Inc., a multinational automotive parts manufacturer; chair of the International Center for Conflict Prevention and Resolution; a board member of the South Florida Wildlife Center; and a trustee of the University of Pennsylvania Carey Law School.
